### Descrição da função

- 1、体系文件搭建与合规更新 / **System Document Management & Compliance Update:** 编制、修订适配工厂实际的ESH体系文件，依据国家法律法规及行业标准实时更新 / Compile and revise ESH system documents adapted to the factory's actual conditions, and update timely in accordance with national laws, regulations and industrial standards.

- 5 **ESH检查 / ESH Inspection:** 开展ESH巡检，排查作业现场隐患，及时制止违规作业及不合规现场状态，协同责任部门整改，跟进落实闭环管理 / Conduct regular ESH inspections, identify on-site hazards, stop illegal operations, cooperate with relevant departments to rectify problems and ensure full closed-loop management.
- 6、全厂合规与专项管控 / **Plant Compliance & Special Management:** 保障工厂合规运营，跟进安全三同时、特种设备、化学品管理、施工作业管理等 / Ensure compliance of plant construction and production, manage safety three-simultaneity, special equipment, chemicals and construction work management etc.
- 7、体系审核与持续改进 / **System Audit & Continuous Improvement:** 配合组织ISO14001 ISO45001等ESH体系内外部审核，跟进审核不符合项整改，落实纠正预防措施，推动体系持续优化 / Cooperate in organizing internal and external audits of ESH systems such as ISO14001 and ISO45001, follow up on the rectification of audit non-conformities, implement corrective and preventive measures, and push continuous optimization of the system.
