- Responsible for the Component Introduction APQP (CI process) of Decorative Plastic Parts. Ensure the selection of qualified suppliers for the components needed.
- Work in sourcing process, execution of Maturity Evaluation, Technical Reviews, Supplier Component Reviews, APQP, R@R, and PPAP validation for components of the assigned category. Ensure proper communication with the different areas of the sourcing and introduction process.
- Handling of Engineering Changes and PCN's for series production components.
- Analysis and troubleshooting of plastic injection molding process and secondary processes (e.g. painting, plating, laser etching, etc.) during the different phases of APQP.
- Execution of VDA 6.3 audits with Suppliers, the assessment and introduction of potential new suppliers in close collaboration with Category Management, R&D and Purchasing BU's.
- Ensure the implementation of Category Quality Standards.
- Work with plant Supplier Quality (SQM CI/SP) for activities in which collaboration is needed, (e.g. escalations, technical support, L/L).
