Main responsibilities are:

- Advising on Al Compliance related matters, including Impact Assessments and the use of Al tools in the company.
- Providing trainings on Privacy and Al Compliance matters
- Supporting in the cross-department Al Council
- Communicating with Data Protection Authorities
- Supporting with documenting privacy relevant processes in the central Record of Processing Activities
- Reviewing data processing activities in the context of commissioned processing and advising on relevant legal requirements, as well as reviewing agreements on commissioned processing
- Supporting with DPIAs and DPNs
- Assisting in identifying and assessing data protection risks including but not limited to DPIAs and DPNs
- Supporting prevention, monitoring, and reporting of data breaches
- · Assisting in preparation for data protection audits
