Main responsibilities are:

- Support the Head of Privacy and AI Compliance with the design and implementation of the Privacy and AI Compliance Management System including but not limited to rules, policies, trainings, communication, monitoring and controls
- Advising on AI Compliance related matters, including Impact Assessments and the use of AI tools in the company.
- Providing trainings on Privacy and AI Compliance matters
- Supporting in the cross-department AI Council
- Communicating with Data Protection Authorities
- Supporting with documenting privacy relevant processes in the central Record of Processing Activities
- Reviewing data processing activities in the context of commissioned processing and advising on relevant legal requirements, as well as reviewing agreements on commissioned processing
- Supporting with DPIAs and DPNs
- Assisting in identifying and assessing data protection risks including but not limited to DPIAs and DPNs
- Supporting prevention, monitoring, and reporting of data breaches
- Assisting in preparation for data protection audits
