- Drive suppliers towards zero-defect strategy, focusing on process capability(CP/CPK), poka-yoke, and mistake-proofing
- Benchmark and share best practices across the supply base to strengthen supplier competence.

Reporting & Documentation

- Maintain up-to-date audit records, PPAP packaging, supplier performance dash boards, and change control logs.
