You will therefore:

- Identify and communicate customs related risks and opportunities to the Head of Customs APAC, your peers in the Automotive Customs team and other stakeholders in the region
- Assist the regional Head and work with the entire customs community in Continental on the development, rollout and maintenance of a customs governance framework, i.e. processes and procedures that ensure consistency, efficiency and sustainability in the area of customs compliance in the region and beyond
- Develop and conduct customs specific training as required by legislation and authorities.
- Implement measures fostering the performance and level of compliance provided by local/regional operational teams, shared service centers and third-party service providers
- Work on customs related requests including timely, accurate and detailed work plans, resource schedules, project estimates and status reports.
- Develop and maintain working relationships with regional customs authorities where appropriate as well as with all other regulatory authorities to carry out company business
- Provide advice and support regarding customs procedures/programs that may reduce duty obligations
- Prepare assessments and reports as required by management
- Monitor legal developments and conduct impact assessments
- Participate in customs audits where necessary
