- Support emergency response and business continuity processes
- Ensure consistent security standards across all locations
- Protection of persons for threat management, including close/executive protection
- Support and advise stakeholders in event security

- Provide clear and regular reporting on:
 - Project status (cost, timeline, risks)
 - Security risks, incidents, and mitigation actions
- Maintain audit-ready documentation
- Ensure compliance with company policies and local regulatory requirements
