- Support China privacy compliance efforts, covering Personal Information Protection (PIPL), automotive sector critical data compliance, and AI deployment and usage compliance. Monitor regulatory developments in China's data and privacy landscape, assess business impact, and drive implementation of compliance measures. Coordinate cross-functional teams (Legal, IT, Business) to ensure effective execution of data governance requirements.
- Design, implement, and continuously improve China anti-trust compliance training programs.
- Support AML-related compliance matters across China operations.
- Serve as the primary compliance contact for business teams, delivering practical, commercially minded advice.
- Independently drive, execute, and manage assigned compliance projects.
- Provide other departmental support as directed by the APAC Compliance Head.
